Notes on Contributors

SimonMary Asele Ahiokhai

is Associate Professor of systematic theology and affiliate faculty of ethnic studies at the University of Portland. He is a Fellow at the Westar Institute, and a former Fellow at the Jesuit Institute/Boston College. His research focuses on Religion and Identity; African approaches to ethics; African philosophies, cultures, and theologies; religion and violence; comparative theology; themes in systematic theology; and interfaith studies. Among his published works is a monograph, titled, *Fostering Interreligious Encounters in Pluralist Societies. Hospitality and Friendship* (Palgrave Macmillan, 2019); and an anthology titled, *Religion, Women of Color, and the Suffrage Movement: The Journey to Holistic Freedom* (Lexington Books. 2022).

Thorsten Botz-Bornstein

is Professor of Philosophy at the Gulf University for Science and Technology in Kuwait. He was born in Germany, studied philosophy in Paris, and received his PhD from Oxford University. He received his “habilitation” from the EHESS of Paris in 2000. He works on comparative philosophy (Buddhism, Daoism, Sufism) and aesthetics on which he has numerous publications. His latest book publication was *How Much Religion Is Good for Us?* (Routledge).

Carol Burke

is a Professor of English and Folklore at the University of California, Irvine who specializes in military culture and veterans. As a folklorist, she embedded with US Army combat units in Iraq and Afghanistan as cultural liaison. Her publications include *Camp All-American, Hanoi Jane, and the High-and-Tight, A Study of Military Culture; Women’s Visions*, a book that explores accounts of the supernatural and the uncanny exchanged by women in prison; *The Creative Process* (coauthored with Molly Tinsley), a creative writing text; *Plain Talk and Back in Those Days*, collections of family folklore – the latter coauthored with Martin Light; and *Close Quarters*, a collection of poems. Articles have appeared in magazines like *The Nation* and *The New Republic* as well as scholarly journals and collections. Before joining the faculty at UCI in 2004, Professor Burke taught courses in literary journalism at Vanderbilt and Johns Hopkins Universities.

Alejandro Carpio

is Professor of Literature and current head of the Hispanic Studies Department at the University of Puerto Rico at Cayey. He has published on Calderon, Cervantes and Borges. He is at present working on a critical documentation of Puerto Rican film and literature over the last 15 years. His novel *El papel de lija* won the 2011 ALBA Award.

Angela M. González Echeverry

is a Visiting Scholar at the University of California, Merced. She has been an Associate Professor in the Department of Humanities at Gulf University for Science & Technology, Kuwait, from 2015 to 2023. She holds a doctorate in Latin American Literature - Humanities/Cultural Studies from Arizona State University, a master's degree in Latin American Literature from the University of Ohio, and a law degree from the University of Caldas, Manizales, Colombia.
